

HESSAY PARISH COUNCIL

MINUTES OF THE PARISH COUNCIL MEETING HELD AT 8.00PM IN THE CHAPEL SCHOOLROOM, HESSAY, ON THURSDAY 8 MAY 2008

Present: Cllrs Roger Hildreth, Mark Barrett, Nick Booth, Amanda Carlyle, and Scott Jefferson. Also present were five members of the public and the Clerk, James Mackman.

In the absence of a Chairman, Councillor Hildreth took the Chair and conducted the meeting.

PUBLIC PARTICIPATION

None.

08.034 - ELECTION OF CHAIRMAN

Councillor Booth was proposed and seconded and unanimously elected as chairman.

08.035 - TO RECEIVE THE CHAIRMAN'S SIGNED DECLARATION OF ACCEPTANCE OF OFFICE

Councillor Booth signed the Declaration.

08.036 - DECLARATIONS OF INTEREST IN ITEMS ON THE AGENDA

Councillors Carlyle and Jefferson declared a personal interest in agenda item 08.040.

08.037 - TO RECEIVE APOLOGIES FOR ABSENCE

All Councillors being present there were no apologies.

08.038 - TO CONFIRM THE MINUTES OF THE PARISH COUNCIL MEETING HELD ON 20 MARCH 2008

The minutes of the meeting held on 20 March 2008, having been circulated and read, were accepted and signed as a true record.

08.039 - TO RECEIVE THE CITY OF YORK COUNCILLOR'S REPORT – FOR INFORMATION ONLY

City Councillor Ian Gillies reported

- The money for the Vehicle Activated Sign will come out of the 2008-09 budget.
- The Wilkinsons sign on the trailer by the A59 is subject to an enforcement order. A planning application has been submitted for the sign.
- The School bus is funded by the NYCC but the City Council pays for seats. The contract is to be re-let for next term so the bus times may change.
- Manor School has a policy that if it is over-subscribed the School Governors give preference to pupils living nearest the school.

08.040 - TO DISCUSS THE SCHOOL BUS JOURNEY TIMES

It was noted that the journey from Hessay to the school in Poppleton takes up to 80 minutes. The contract for the service is to be re-let. It was agreed that a letter be sent to York Transport Provision to ask that the new service reduces the time for delivering the children. (**Action Clerk**)

08.041 - PLANNING APPLICATIONS - *To note Local Authority Planning Decisions*

It was noted that the Local Planning Authority had refused the following application:

Ref: 08/00127/FUL – Erection of 2no. storage buildings following demolition of existing buildings (resubmission) at Mizpah Cottage, Shirbutt Lane by Mr & Mrs Craggs.

08.042 – TO RECEIVE A REPORT ON THE VILLAGE QUESTIONNAIRE ON

(a) Parish Land

A “Parish Council Memo” had been sent to all Hessay households giving details of various subjects relating to the Parish Council including a selection of the results from the survey. These included:-

- Hessay needs more community facilities - 31% strongly agreed
- Parish land should be used in such a way that its wildlife is maintained and encouraged - 50% strongly agreed
- Where appropriate Parish Land should be rented out to provide an income for the parish council - 58% agreed
- Parish owned land should be used for the greatest long term benefit of the whole village - 50% strongly agreed
- The play ground would benefit from equipment to appeal to children over 5 years old - 42% agreed
- The use of parish owned land provides the greatest benefit to the whole village - 35% no opinion
- Parish land needs to retain the rural aesthetics of the village - 50% strongly agreed
- Use of Parish Land need to be sensitive to the rural environment - 50% strongly agreed

(b) Cycle routes

Also included in the Parish Council Memo were the following notes:-

- The City Council (CYC) is going through transport funding for all transport methods, including Park and Ride and cycle routes.
- As part of the Local Development Framework (LDF) there is a North West Action Plan. Part of the Plan includes an initiative to develop a route linking the Holgate Road Railway site to Wyevale, along with a proposed park and ride facility which includes a cycle route from York to outer York.
- The Hessay cycle route initiative fits with North West Action plan and CYC is hopeful of attracting Sustrans funding.
- There remain a number of route options for a cycle path between Hessay and York though nothing has been agreed as yet. The village survey revealed some strong views on the unsuitable nature of the A59 and we are therefore keeping in touch with the CYC to see what other options might be possible.

08.043 - TO DISCUSS PARISH COUNCIL COMMUNICATION WITH RESIDENTS

Prior to the Annual Parish Meeting a Parish Council Memo, as mentioned in the minute above, had been delivered to all residents. This gave notice of the forthcoming meetings, a summary of the results of the Questionnaire, an update on Traffic Management and the proposed Cycle Route.

08.044 - TO DISCUSS PROTECTION FOR THE HESSAY/UPPER POPPLETON BOUNDARY STONE

No progress had been made on this subject. It was agreed that a fence be erected round the stone to protect the stone from cattle. The stone itself would be unaffected.

08.045 – TO CONSIDER A LETTER REQUESTING SUPPORT FOR A PETITION AGAINST THE REDUCTION OF THE VALUE OF SENIORS’ TRAVEL TOKENS

It was agreed that the Parish Council would not support the petition and a letter to this effect be sent to the organiser of the petition. **(Action Clerk)**
