##### *(a) To consider the following Planning Applications*

Ref: 09/01029/FUL – Change of use of unit 5 to builders storage yard, erect new gates and blockwork wall at Unit 5 Springbank Business Park, York Road by Mr K Marsden.	We object to the planning application on the following grounds. <ol style="list-style-type: none"><li>1. That the unit is to be used for skips (see design access statement) necessitating visits by HGVs.</li><li>2. That the vehicle turning area is used for vehicle parking therefore forcing large lorries to reverse into the site from the A59.</li><li>3. That the new gates will restrict access to both the 5-vehicle parking area at the southern end of the site and the communal refuse area.</li></ol>
